Teachers will use assessment data to determine students' specific academic needs and deliver specific interventions based on students' needs. This instruction will include small group as well as individualized instruction. We are implementing a team teaching model to allow for even more differentiation and lower student to teacher ratio.

We will continue to implement high leverage practices, ensuring that every student has access to grade-appropriate assignments, strong instruction, deep engagement, and are held to high academic expectations. Through observation and feedback, student work analysis and data meetings, our leadership team will support teachers in delivering high quality instruction that accelerates learning for all students. This work will be supported through targeted professional development and vertical team collaboration.

Students who are the most at risk will have targeted instruction delivered by classroom teachers, tutors and volunteers. Four years ago, we added an intervention coordinator to our staff so that our interventions can be more strategic and more robust. Additionally, we are implementing a team teaching model. By utilizing a team teaching model, classroom teachers will be supported in providing small group literacy and math instruction and classroom-based interventions.
